Invitation for Bids

1. Umakunda Rural Municipality, Preeti, Ramechhap has allocated funds or received a grant from Government of Nepal towards the cost of following **Construction of Umakunda Rural Municipality Project** and intends to apply part of the funds to cover eligible payments under the Contract mentioned in para 9. Bidding is open to all eligible Nepalese Bidders.
2. Umakunda Rural Municipality invites sealed bids from eligible bidders for the following **Construction of Umakunda Rural Municipality project under National Competitive Bidding (NCB) procedures**. Only eligible bidders with the following key eligibility criteria should participate in this bidding
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Umakunda Rural Municipality Office, Preeti, Ramechhap, Tel no. **046-691927**, Website: **www.umakundamun.gov.np**. A complete set of Bidding Documents may be purchased from the Umakunda Rural Municipality Office, Preeti, Ramechhap by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3000.00 (three thousand) till 17.00 hrs, on **2076/12/21(3<sup>rd</sup> April, 2020)**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
5. Sealed bids must be submitted to the Umakunda Rural Municipality Office, Preeti, Ramechhap by hand/courier on or before **12:00hr on 2076/12/23 (5<sup>th</sup> April, 2020)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00hr of 2076/12/23 (5<sup>th</sup> April, 2020) at the Umakunda Rural Municipality Office, Preeti, Ramechhap. Bids must be valid for a period of 90 (ninety) days after bid opening and must be accompanied by a bid security amounting to a minimum of **following below** which shall be valid for 30 days beyond the validity period of the bid
7. If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Name of the Bank: **Sunrise Bank, Preeti Branch**, Name of Office: **Umakunda Rural Municipality Office, Preeti, Ramechhap**, Office Account no.: **0960568577703003** and the receipt of the deposited amount of cash should be submitted along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
